

British East Asia Postal Stationery Catalog

Errata and Corrigendum This list only covers errors that affect catalog numbers or prices. Grammer errors, obvious mistakes, and changes to text that are not critical to identifying an item (such as quantities printed, etc.) are not included here, but will be addressed in next edition.

Page 3, 1st paragraph should end with Types **C** and **CC**.

Page 6, Watermarks: After the word “London” in type (ii) there should be a new paragraph starting with: (iii) **those intended etc.**

Page 13: E16 is 5c red **die 2**.

Page 14: The example of P54r has **3c** blue indicium

Page 24 lower right illustration is of **E17**.

Page 26: P9 on surcharged on **8c** brown.

Page 29: P43U should be **P43r**.

Page 33: P73 should be: **3c** die 1 & 3c grey die 2

Page 39: The note after L20 & L21 applies to L20.

Page 45: E80 is knife **f4**.

Page 46: Add following note after E83:

Note: E73 and E74 should be compared to E103 and E104 that have the same knives.

Page 48, **1949 07?** Text: The spacings between **5** and **c** are reversed. Type 1 should be **1.0 mm** and Type 2 should be **1.2 mm**.

Page 48: The price of E165 should be **♣ 500**

Page 50: RE33 – RE40 are **10c**

Page 54: **1926 06 01**. Penultimate sentence should state Definitive 2c wrappers in the new large size **are in olive-yellow**.

Page 56, **1945 01** text: “with the same three text lines as **A1**.”

Page 58: The second variety of A20 should be **A20v2**.

Page 59 second column. A27 and A27v1 should be **A31** and **A31v1**.

Page 62: FA7 should be **T-III**

Page 67: PO.G2 is **1 Rupee**, not 1.50 Rupees.

Page 68: P125-P127 should be **P124, P125, P126**

Page 69. Renumber P125, P126 and P127 to **P124, P125** and **P126**.

Page 70: P160 and P161 should be **4.00**.

Page 71: P116 should be **P162**.

Page 75. GP0 at the bottom of the page should be **GP21**.

Page 81: The unnumbered item after AE1 should be **AE2**

Page 86: The second A61 should be **A62**.

Page 96: The price of P12r is **\$1,250**.

Page 98 following **1941 04 15**: The rate for envelopes was increased to **8c**.

Page 98: P48 should read **2 CENTS+2c orange**

Page 103, Negri Sembilan E2 & E3: Surcharge added to raise rate to **8c**. The listing should be: **3 cts+5c** brown for both

Page 104, Pahang E2 & E3. Surcharge added to raise rate to **8c**. The listing should be: **3 cts+5c** brown for both

P105, Perak E3, E4 & E5. Surcharge added to raise rate to **8c**. The listing should be: **3 cts+5c** brown for all three

Page 106, Selangor E2 to E6. Surcharge added to raise rate to **8c**. The listing should be: **3 cts+5c** brown for all.

Page 107. The first registration envelope should be **RE1**.

Page 117: Numbers FE2 – 4 should be **FA2 – FA4**.

Page 118: the third from the bottom paragraph has the following sentence: These can only be distinguished by the dates on the cancels (**February** to August 1942).

Page 119: Kedah P6 should be **P9**.

P120: Note 1 after RE8 should state “of P7 and one of **P10** have etc.)

Page 121: Paragraph before **1942 03 16** revised as follows: These issues were the **second** Malaya-wide postal stationery (**The first being the Malay Posta Union’s postal orders**).

Page 122: Last sentence of first paragraph: **P16** and P19 also etc.

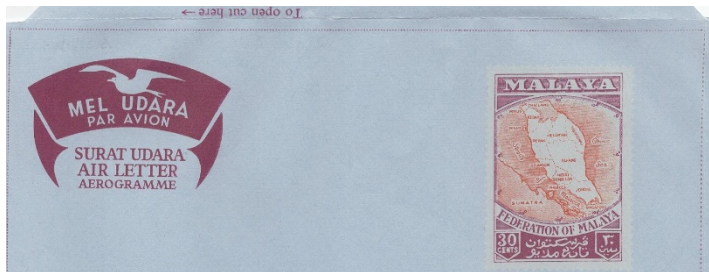
Page 122: last registration envelope is number **RE27**, not RE17.

Page 142: **1954 09?**, Delete the following text: (**Illustration on next page**).

Page 145: The illustrations for A13 and A14 are incorrect, and should be as follows:

Page 147: The price for DP19 is \$160.

Page 153. Replace the text following P4v1 with the following:

1890 06. The printer had prepared a plate taken from a 1886 stamp die (with small POSTAGE) for the indicium and printed a quantity before changing the die to conform to a new stamp design with POSTAGE & REVENUE. The latter cards were rejected by the British North Borneo Company after a few (a dozen?) samples had been made. The final version, with a large POSTAGE, is P1 (A more detailed history is given in Appendix E). The philatelic press first announced the discovery of a new type in mid-1890, and another later that year. It is likely the printer had inadvertently included a few of the earlier trial cards in the stock sent to the Company's London offices intended for philatelic dealers. P6U was never intended for release, but P5 was eventually issued circa 1909 in Borneo after being in storage for about 19 years.

Page 158: Note 4 after RE15 should read: It is not clear why Sarawak changed the color to brown, as the UPU regulations stipulated **blue color** for registry service.

Page 161: The overprinted Brunei registration envelope is **RE1**, not E1.

Page 171 and 172: Delete second E23 and remaining numbers are correct. E22-E30 are in order of the numbering printed on them (1/10, 2/10 3/10, etc.)

Page 178 **1976 02:** Last sentence should read: A6 has same MI as **A4-5**. **A7** has etc.

Page 184: Paragraph under Die III and IV illustrations. Replace sentence with the following:

The mistake was **discovered before any sales**, and the error was handstamped with an **H** and black bar to hide the **G**.

Page 191: The second VP4 should be **VP5**.

Page 195: The second CAP4-03 should be **CAP4-04**.

Page 201: Note after RE39: Die II has been reported on size **L**, but has not been verified

Page 202: Following A21 should be **A21v1**.

Page 204: Renumber A44-46 to **A45, A46, A47**.

Renumber A48-A49 at bottom of page to **A50, A51, A52**.

Page 207: The correct number for the 10c / \$1 black and pink postal order is **PO.B1**.

Page 216: Note under P44: P48-**P53**, and GP1-GP12 include etc.

Page 224: RE63 is Type 1 and RE64 is Type 2. The denomination of RE66-RE68 is **30c**.

Page 234: RE66-68 are **30c**.

Page 244: the price of P138 should be **\$3**.

Page 227 top of right column: W4 should be **W5**.

Page 228: A3 text length should be **25.5 mm**.

Page 260: renumber OP1-OP3 to **OP2-OP4**. New prices:

OP2 ★ 25
OP3 15 45
OP4 35 55
